1. The Department of Education (DepEd) Region VII implements measures to undertake appropriate response to help curtail the threat of COVID-19 especially in Offices and schools.
2. For information, in a directive given by President Rodrigo Roa Duterte, the IATF issued Resolution No. 148-B which takes effect on December 1, 2021, mandates employers in the public and private sector shall require eligible employees who are tasked to do on-site work to be vaccinated against COVID-19. If remain to be unvaccinated, they shall be required to undergo RT-PCR tests regularly at their own expense for purposes of on-site work or antigen tests if RT-PCR is not immediately available.
3. The Office is waiting for an Order as to implementation of the said guidelines.
4. Attached is the IATF Resolution 148-B, for reference and guidance.
