

Date : December 7, 2021

In view of the general preparations conducted for purposes of the forth coming May 9, 2022 National and Local Elections, you are hereby directed to wit:

1. Conduct ocular inspection on all voting centers within your respective areas of responsibility for purposes of determining their fitness and readiness for election use.
2. Identify voting centers within your respective areas of responsibility which are currently utilized as covid centers/facilities.
3. Coordinate with your respective LGUs and DepEd Supervisors/Principals regarding the matter of guaranteeing that all voting centers currently used as covid centers/facilities will be vacated/cleared and disinfected not later than March 31, 2022 to ensure their fitness for use during the May 9, 2022 National and Local Elections.
