**CLARIFICATION ON DepEd TASK FORCE COVID-19 (DTFC) MEMORANDUM No. 575
"IATF VACCINATION REQUIREMENT FOR PERSONNEL REPORTING ON-SITE
BEGINNING DECEMBER 1, 2021"**

1. The Department of Education (DepEd) encourages all teaching and non-teaching personnel to be vaccinated as a matter of protecting the lives and health of everyone amidst COVID-19 pandemic.
2. DepEd reiterates that all actions implemented are consistent with IATF Resolution Nos. 148- and 149, s. 2021 and in accordance with the provisions Republic Act No. 11525.
3. In view of this, the Schools Division Superintendents (SDOs) are enjoined to observe the following clarifications in implementing the IATF Resolution Nos. 148-B and 149 with Central Office clarifications through DepEd DTFC Memorandum No. 575 :
 - a. NVOC/RVOC/LVOC certification of sufficiency of vaccine whichever is available suffice the requirement for the implementation of IATF resolution;
 - b. Illegible unvaccinated personnel can be allowed to report on-site provided a negative RT-PCR/Anti-gen Test results be presented at the expenses of the employee;
 - c. Ineligible unvaccinated personnel likewise shall present negative RT-PCR/Anti-Gen Test at the expense of the school/SDO through its MOOE, subject to COA rules and regulations.
4. Proper coordination with the LGU or Local Vaccination Centers concerned is enjoined.
5. Dissemination and compliance of this Memorandum are desired.
