

This is to reiterate the instruction in the February 9 LDM memo that regional LDM program management teams facilitate the issuance of certificates of participation, as mentioned in the evaluation guides issued last year through bit.ly/l dm1evalslide and bit.ly/l dm2evalslide . 2. Regional LDM focal persons are also instructed to accomplish their regional LDM Form 4 (list of completers) and submit this list to lpcapbldg@gmail.com . This is done by consolidating the LDM Forms 4 from all the SDOs..

In relation to this, LDM 1 and 2 certificates --both the theoretical (participation) and practicum (completion) parts--can be used by teachers, school heads, and supervisors for their application for reclassification/promotion as these courses both passed the professional development recognition process of the department.
