### TO: SCHOOLS DIVISION SUPERINTENDENTS

- 1. Notwithstanding from the actual trained teaching personnel, another essential indicators of the budget utilization were the increase in percentage of schools conducting of LAC Session. For this year, amidst the pandemic situation, as indicated in the scarcity and lack of stable internet access in some areas, some schools were not able to focus in conducting LAC Sessions.   - d. Refrain from changing the template.
  - e. Submission of all encoded data shall be on or before 10:00PM. of 21 January 2021. After 10:00PM., it will be turned off the sharing of the document so as to finalize the data provided.
