- 4. To private schools who have not yet responded and accomplished the required online form as specified in Regional Memorandum No. 0451, s. 2020 dated September 2020, they are reminded on the following instructions:
  - Submit an official email address of the school that will be used to accomplish the online form to the SEPS M & E of the division office where the school belongs.
  - Concerned schools should accomplish the online form only once within the prescribed period.
  - > The response may be edited after the submission by clicking the "Edit your response" link/button if there are necessary corrections. Please be reminded that once the browser is closed, the "Edit your Response" link may no longer be available.
  - > Check first the printed form in order to identify and prepare the necessary documents needed before accomplishing the online form.
  - All documents to be uploaded in the online form are required to be in the PDF format. Respondents are advised to check for applications available to convert documents of any format to PDF before accomplishing the form.
  - For multiple documents, combine it into one PDF file. Example, multiple GPP documents representing the number of times that a provisional permit was granted to the school, must be combined and merged into one PDF file.
  - For private schools whose Government Recognition Certificates (GRC) that were issued under the previous Negros Island Regional Office or NIR, they are advised to drop the letter R to match the given format in the online form of the google sheet under "No. 92. 5.3.1. A GRC Number (Preschool)"
  - Format #### s. yyyy (Ex. 0001, s. 2020).
  - This is due to client feedbacks fram the field.
- 5. Schools Division Offices SEPSIM & Eishall ensure that all private schools in their Division have correctly accomplished the required forms and have submitted the same to the region.
- 6. The online form through the given link is still open to accept responses up to February 15, 2021.
- 7. Meal expenses for DepEd RO7 participants (breakfast and lunch with two sets of snacks) to be served by the Applied Nutrition Center shall be charged to Regional Office funds.
