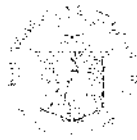

4. Appeal Impact	20%
Total	100%

b) **DRRM Battle of Spoken Poetry**

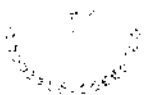
CRITERIA	SCORE
1. Relevance to the Theme	40 %
2. Creativity/Style and Originality	30%
3. Coherence of form and structure (harmony of words, presentation)	20%
4. Clarity of imagery and language	10%
Total	100%

3. The link and the platform to be used on this activity will be forwarded one (1) day before the scheduled activity.


