1. As part of the after-training activities of the LDM 1 course (Management of LDM Implementation) for school heads, the National Educators Academy of the Philippines (NEAP) is directing school heads to access and accomplish the Learning Delivery Modalities Readiness Assessment Tool (LDM RAT) for Quarters 2-4 (midline assessment) through bit.ly/ldmready234 on or before 5 February 2021 (Friday).
2. An end-line assessment tool will be deployed after the fourth grading period to help you track the LOM implementation progress you have made this school year. Data generated from the RAT (midline and end-line) will form part of the practicum portfolio, and may also be used by school heads and other offices for action planning, progress monitoring, and decision-making. The tool and submission details are posted in the given link.
3. The Office of the Undersecretary for Planning, Human Resource and Organizational Development will also be issuing a memo on Regional Progress Monitoring Report on the Implementation of BE-LCP Programs which cites the provisions in items 1 and 2.
4. LDM focal persons in the SDOs, in coordination with focal persons in the RO, are also instructed to do the following:
 - a. update their SDO's LDM trackers through bit.ly/ldmneaptrackers; and
 - b. submit/upload LDM evaluation forms (Forms 1, 2 and 4) to your respective Google drive folder. Submission details are shared in the following links:
