



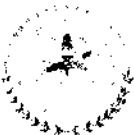
**QUALITY ASSURANCE OF LOCALLY DEVELOPED EsP MODULES**
