The **DepEd, Division of Negros Oriental**, through the Flexible Learning Options (FLO) intends to apply the sum of **Four Million Four Hundred Sixteen Thousand One Hundred Seventy Pesos Only (Php. 4,416,170.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

1. The **Department of Education, Division of Negros Oriental** now invites bids for **PROVISION OF PRINTING SUPPLIES FOR THE REPRODUCTION OF LEARNING RESOURCES UNDER THE IMPLEMENTATION OF BE LCP**. Delivery of the Goods is required during the above mentioned contract completion time. Bidders should have completed, within *[insert relevant period]* from the date of submission and receipt of bids, a contract similar to the Project. 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and

2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

In addition, select one of the two following paragraphs and delete the other depending on the existence of conditions under Section 23.4.1.2 of the IRR of RA 9184:

(i) Select this paragraph if conditions (a), (c), and (d) under Section 23.4.1.2 of the IRR of RA 9184 do not exist: Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

(ii) Select this paragraph if condition (a), (c), or (d) under Section 23.4.1.2 of the IRR of RA 9184 exists: Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

3. Interested bidders may obtain further information from **DepEd, Division of Negros Oriental** and inspect the Bidding Documents at the address given below during 8:00AM to 5:00PM (Monday to Friday).
4. A complete set of Bidding Documents may be acquired by interested Bidders on **March 18, 2021 until the opening of bids** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (Php. 5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The **Department of Education, Division of Negros Oriental** will hold a Pre-Bid Conference³ on **9:00 A.M., March 24, 2021** at **SGOD Office Conference Room**, which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat at the address below on or before **April 05, 2021, 10:00 A.M.**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
