1. The **Provision of Self-Learning Modules (SLMs) Quarter 4 SY 2020-2021 Re-Bidding**, through the **FLO/RO VII-21-243** intends to apply the sum of **Php. 11,700,624.00 (Eleven Million Seven Hundred Thousand Six Hundred Twenty-Four Pesos Only)** being the ABC to payments under the contract for:

Bidders should have completed, within Forty-five (45) Calendar Days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

After verification from the bank, the bidding documents will be sent through email provided that the bidder shall print the bid documents and submit them to the procuring entity as a requirement among others before the awarding of contract.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **9:00 A.M., September 6, 2021**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
