**CAPABILITY BUILDING ON LEARNING RESOURCE DEVELOPMENT
AND QUALITY ASSURANCE**

To: Schools Division Superintendents (SDSs)
All Others Concerned

1. In response to ensuring availability of appropriate learning resources for learners with special educational needs, this Office, through the Curriculum and Learning Management Division will conduct a Capacity Building on Learning Resource Development and Quality Assurance on **November 22-26, 2021 via MS Teams**.
2. The activity aims to:
 - a. capacitate the participants on the roles and responsibilities of development and quality assurance team, and on the general specification of ADM LR's;
 - b. go over the LR standards and evaluation process;
 - c. discuss the evaluation guidelines and improvement process of learning resources; and
 - d. develop and evaluate SPED learning resources.
3. Participants to the activity are the CLMD Chief, supervisors and staff, and 28 participants coming from each schools division offices (10 SPED teachers, 8 receiving multigrade teachers, 4 school heads, 4 PSDS, Division SPED focal and Division multigrade coordinator). They must use laptop during the training and maximize the learning opportunity by staying in the place with stable internet signal. They are required to pre-register through the link: <https://forms.gle/2wbs1Gkfn522tK96>.
4. In accordance with the provision of DO No. 19, s. 2011 and DO No.53 s. 2003, teacher-participants shall be entitled to service credits. In addition, MS Teams meeting link shall be sent through the Division SPED Focal Persons who will in turn forward the link to the selected participants.
5. Food expenses for the participants reporting onsite, which shall be served by DepEd ANC, shall be charged against OSEC 7-21-3567 while communication expenses of the participants shall be charged against Division/School MOOE, all subject to the usual government accounting and auditing rules and regulations.
