DATE : April 14, 2021

1. The Rapid Assessment of Damages Report(DepEd RADaR) is a mobile and web app developed by DepEd, in partnership with Save the Children Philippines (SCP) and Prudence Foundation, that aims to quickly report impacts of different natural hazards in the schools in terms of infrastructure damages, personnel casualties, classrooms used as evacuation centers, temporary learning spaces needed, as well as non-infrastructure damages such as furniture, learning resources, and computer sets.

2. In order to validate the school account registrations and discuss the importance of the app during emergencies, the Schools Division of Negros Oriental through the Disaster Risk Reduction and Management (DRRM) will conduct a **DepEd RADaR Mobile App School Account Validation and Planning Conference for EIE Training Workshop** on April 22, 2021 at DepEd NegOr 3rd Floor Conference Room.

3. Travelling and other incidental expenses of the participants shall be chargeable against school MOOE/local funds while lunch and two snacks be charged against DRRM Funds all subject to the usual accounting rules and guidelines.

4. **Participants to this conference are required to bring face masks, face shield and hand sanitizers. Minimum guidelines and protocols set by the DOH, IATF, and other agencies shall be observed at all times during the activity.**
