2. Conduct a joint (Sta. Catalina 1, 2, 3, 4) investigation on the twenty three (23) COVID cases as listed on the attachment as a contributory factor on the surge of COVID-19 cases in the municipality.
3. To submit to this Office result of the joint investigation re the contribution of the twenty three (3) personnel to the surge of COVID cases in the municipality.
4. Furnish the municipal IATF of the district memorandum as well as a copy of the result of the joint investigation.

Immediate compliance of this memorandum is hereby enjoined.

**WHEREAS**, that the above 23 Dep Ed Personnel, this municipality was able to swabbed at least 500 individuals who were exposed either as first or second-generation contacts to the above mentioned Dep Ed Personnel;

**WHEREAS**, a total of at least 6 who attended the aforesaid gathering or has been a first generation or second-generation contact tested positive for COVID-19;

**WHEREAS**, that in order to deter subsequent violation of the National, Provincial and Local IATF Guidelines, and existing laws on mass gathering, fiesta celebrations, parties, karaoke sessions and related gatherings in the municipality;

**WHEREFORE**, on motion of Ms. Romelyn Saguban duly seconded by Ms. Idy Mae P. Electona, the Municipal Anti-COVID19 Task Force of the Municipality of Santa Catalina

**RESOLVES**, to REQUEST the District Supervisors of the Districts 1, 2, 3 & 4, this municipality to strictly REITERATE to their respective Dep Ed Teaching Personnel and Non-Teaching Personnel to adhere to the National IATF Guidelines on mass gathering, parties and fiesta celebrations and to reprimand and or impose sanctions to Dep Ed personnel who violates the same.

**RESOLVES further**, to recommend to the following, viz:

- a) Reiteration on the Strict Implementation of Municipal Ordinance No. 2020-32 on Minimum Public Health Standard;
- b) Conduct periodic monitoring on the observance of National IATF guidelines.
- c) Reiteration on the Strict Implementation all National Inter-Agency Task Force (NIATF) guidelines especially on mass gathering, parties and or celebrations which the same should and must be limited to immediate family members; &

**RESOLVES further**, to request the Division Superintendent to discipline and or impose sanctions to Dep Ed Personnel who violate the National Issuances especially by the NIATF on mass gathering and convergence of people especially fiesta celebration.

**RESOLVES finally**, to copy furnish thus resolution to concerned office or agency, for guidance and appropriate action,

#### **RESOLUTION NO. 17-2021**

**WHEREAS**, Section 15, Article II of the 1987 Constitution mandates that each Local Government Unit (LGU) shall take responsibility in the promotion of health and shall ensure safety of its people within the territorial jurisdiction;

**WHEREAS**, pursuant to Proclamation No. 922, dated March 8, 2020, issued by the President of the Republic of the Philippines declaring the entire country under State of Public Health Emergency, LGU's are enjoined to render full assistance and cooperation, mobilize necessary resources to undertake critical, urgent, appropriate response and measures in a timely manner to and eliminate the COVID-19 threat.

**WHEREAS**, to mitigate response and to prevent contamination, cross contamination and or spread of COVID-19, Municipal Anti-COVID-19 Task Force was created who shall formulate necessary measures, interventions and guidelines on the prevention, control, monitoring, and information dissemination relative to the risk of contracting COVID -19, this municipality;

**WHEREAS**, Section 2(c) of E.O. 168 mandates the IATF to prevent and/or minimize the local spread of emerging infectious diseases in the country through the establishment or reinforcement of a system in screening possible patients infected with emerging infectious diseases, contact tracing, identification of the mode of exposure to the virus, and implementation of effective quarantine and proper isolation procedures;

**WHEREAS**, that National Inter Agency Task Force (NIATF) placed the entire Province of Negros Oriental under Modified General Community Quarantine (MGCQ) from April 1-31 & May 1-31, 2021;

**WHEREAS**, that Municipal Ordinance No. 2020-032 was enacted September 08, 2020
