1. Regional ALS Focal Persons are expected to conduct its own internal ALS PIR to assess Regional and/or Schools Division Office ALS FY 2020's PAPs:
2. They are expected to record and send their Accomplishment Report **(word file and powerpoint)** on the Utilization of ALS Program Support Funds for CY 2020 (*Enclosure No. 3 of DepEd Order No. 33, s. 2020*), and FY 2021 Enrollment as of February 6, 2021;
3. Prepare a **full blown narrative report and photo documentation** (if possible) of the annual accomplishments which include the following parts:
  - a. Highlights of Accomplishments in terms of Committed Outputs/Milestones;
  - b. Financial Accomplishments;
  - c. Bottlenecks for the Year and its status;
  - d. Lessons Learned;
  - e. Targets that will spill over the next fiscal year; and
  - f. Ways forward which include summary of action plan; and
4. Initial proposed programs/activities for the allocation of FY 2021 Program Support Funds (initial PSF allotment is 7 Million per Region), to include:
  - a. Support to Operations expenses;
  - b. Trainings and Capability Building activities; and
  - c. Reproduction/Printing of teaching and learning resources.
