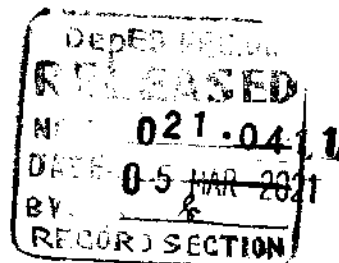



**CONSULTATIONS ON THE NEEDED INSTRUCTIONAL MATERIALS FOR
 KINDERGARTEN AND SPED**

To: Schools Division Superintendents (SDSs)
 All Others Concerned

1. This Office, through the Curriculum and Learning Management Division, will conduct online Consultations on the Needed Instructional Materials for Kindergarten and SPED on March 8-11, 2021 and March 29-31 respectively, via Google Meet.
2. The activities aim to:
 - a. review thoroughly the Learning Resources and other pertinent references in Kindergarten and SPED;
 - b. create standard lists of the instructional materials needed in the implementation and delivery of the curriculum specifically for Kindergarten and SPED; and
 - c. guide the kindergarten and SPED teachers in the preparation and provision of IMs to the learners;
3. Participants to the activities are the CLMD Chief, selected Regional Supervisors and staff, as well as the following from each division:

For Kindergarten

 - Division Supervisor in Kindergarten
 - 2 Kindergarten Teacher
 - 1 District/Cluster Kindergarten Coordinator

For SPED

 - Division SPED Focal Person
 - 1 Teacher for LWD (non-graded class)
 - 1 VI Teacher
 - 1 HI Teacher

In the selection of participants, the SDOs are encouraged to choose performing teachers and coordinators in kindergarten and SPED, and must have laptop and strong internet connection.
