

REVIEW ON THE ADDITIONAL CURRICULUM FOR LEARNERS WITH VISUAL AND HEARING IMPAIRMENT

To: Schools Division Superintendents (SDSs)
All Others Concerned

- 1. This Office, through the Curriculum and Learning Management Division, will conduct a Review on the Additional Curriculum for Learners with Visual and Hearing Impairment via Google Meet on February 8-11, 2021.
- 2. The activity aims to:
 - a. review thoroughly the additional curriculum for learners with visual impairment and the adapted K to 3 Most Essential Learning Competencies (MELCs) for learners with hearing impairment;
 - b. discuss the policy provisions on learners with disabilities as well as the basic information of hearing and visually impaired learners;
 - c. write supplementary learning activity sheets on difficult/least learned competencies in the additional curriculum; and
 - d. provide support on the successful implementation of the additional curriculum.
- 3. Participants to the activity from each division are the following:
 - Division SPED Focal Persons
 - 2 SPED teachers handling Visually Impaired (VI) Learners
 - · 2 SPED teachers handling Hearing Impaired (HI) Learners
 - 2 Receiving/Regular teachers handling either HI or VI in an inclusive setting
 - 1 PSDS
 - I Principal
